EADM funding available: To stimulate activities in the two-year gap between SPUDM conferences, EADM sponsors up to two workshops or similar events per year, up to a maximum of EUR 3,000; to be decided upon per proposal. Proposals with applications for funding can be sent to the EADM Treasurer, Bernd Figner via email treasurer@eadm.eu. Deadline for applications is January 31 of each year. A decision will be communicated after the board meeting mid-March of the same year.

Applications should include the title of the workshop/event, provisional date, location, organisers, background, aims and objectives, provisional schedule, itemised budget, additional sources of support, references. A series of requirements have to be met, such as that the main organizer has to be an EADM member and that the organizers are willing to present a short summary of the workshop/event at the members' meeting of the next SPUDM follwing the workshop/event. JDM update: Since January 2023, *Judgment and Decision Making* (JDM), the official journal of the European Association for Decision Making (EADM) and the Society for Judgment and Decision Making (SJDM), moved production to **Cambridge University Press (CUP)**. This ensures the journal's sustainability and means that the journal now benefits from opportunities that are afforded by having a strong publishing partner. Importantly, the journal also retains its unique features, including the fact that the journal remains entirely open-access, appears on the web (only), and has no publication charges for the vast majority of authors.

The editors (Jon Baron, Mandeep Dhami, and Andreas Glöckner) want to assure authors that publication charges are only payable if (a) authors are not from institutions that have a publishing agreement with CUP, and (b) if authors have at their disposal earmarked funds for publishing costs. If only (a) applied but not (b), authors can **apply for a waiver** of publication costs during the submission process, which should by default be granted by CUP. The Editors **invite submissions** to the journal. Articles are now published on a rolling basis to ensure their rapid availability, all articles in a year are now published as one 'annual' issue. To find out more see the following link:

Social safety: It is important to verfy that all feel safe and welcomed at EADM events. This is typically how many of experience those events, but it seems that this is not always the case. To provide clarity on what is expected from those attending EADM events, we are introducing a new code of conduct (effective from now onwards). You can read the **code of conduct** on EADM's website, in the 'about EADM' section: https://eadm.eu/who-are-we/code-of-conduct/. Beyond providing clarity on desired behaviour, we also provide a direct actionable item for future SPUDM and other EADM event organizers, asking them to appoint a social safety contact person for the duration of the event, and clarify to participants how this person could be reach if needed.

EADM's bylaws revisited: EADM is a formal association listed in the Dutch Chamber of Commerce. Accordingly, we have bylaws that regulate how the association is organized. Our current bylaws were written a long time ago. For example, they state:

The fee for Members is at present 60 Dutch Guilders (or the equivalent in English Pounds or D-marks at the exchange rate prevailing on 2 January of the year in question).

We think it is time to update those bylaws. The updating will take place in the following way:

- 1. We provide members who are subscribed to the mailing list with a link to the bylaws. It is a word document in which we have used track changes to document the changes to the old version.

- 3. We invite those who would like to comment on those proposed changes to send us their comments before the end of September 2024 (secretary@eadm.eu). Important: when sending us your feedback please include your proposed version of any item you are commenting on.
- 4. During the member's meeting at SPUDM 2025, we will introduce the bylaws after considering all feedback. And members will vote on those proposed changes before a notary can submit those to the Chamber of Commerce.
