SPUDM 2025 Summary

Reflections from the EADM President – Mandeep K Dhami

Every two years, we come together from across Europe, North America, and increasingly from other corners of the globe to share the knowledge we have created, learn about new discoveries in our field, and refresh our collaborative networks.

In 2025, over 400 of us from four continents met in the ancient walled city of Lucca, which is set against the stunning backdrop of Tuscan hills in Italy. From the 31st August to 4th September, we witnessed 250 full talks, 44 flash talks, 60 posters, 41 talks organized into 11 symposia, 4 keynotes, and 4 presentations from

prize winners.

Aside from knowledge sharing in a formal setting, we were able to continue our conversations over break and lunch periods in the garden. Early career scholars had the opportunity to social with their peers, and seek out valuable career advice from more experienced scholars at specially organized events. Indeed, this year EADM was able to financially support 12 individuals to attend the meeting. Together, we were all able to witness a display of the traditional Tuscan art of 'flag throwing', and enjoy a social evening of delicious Italian food and beverages, listening to live music under the stars.

Perhaps the most unique aspect of SPUDM 2025 was the fact that as scientists we gathered in a complex containing a beautiful church, and many of us presented



our work in this church. Science and religion are often considered to be inherently incompatible and even in conflict. In our case, the church had been deconsecrated, making way for science.

This reminded me of the two main schools of thought in our field (i.e., coherence and correspondence) that often appear to be competing and conflicting in their efforts to understand and improve human JDM. In my Presidential Address (which is summarized on the EADM website, and will eventually be published in full), I took the opportunity to suggest that rather than present incompatible and conflicting conclusions, the two main schools of thought ought to move forward together to scrutinize the decisions of the most powerful actors in our society i.e., court judges, and in doing so, to value justice as a decision outcome. I hope that JDM scholars will take up this call to action.

At SPUDM, we also gather to recognize the talents of students in our field, early career researchers and experienced scholars.

Karl Teigen (University of Oslo, Norway) received the <u>lifetime contribution</u> award in recognition of his contribution to the community of decision-making researchers and EADM in particular.

In recognition of innovation in decision research as broadly understood within the SPUDM tradition the <u>Jane Beattie prize</u> was awarded to **Shoham Choshen-Hillel** (the Hebrew University Business School, Israel). The runner up was **Peter Kvam** (Ohio State University, United States).

This year the <u>De Finetti prize</u> for outstanding research by PhD students in the area of decision making was shared by two winners, namely, **Linh Vu** (University of Amsterdam, The Netherlands) for the paper "Ignorance by choice: A meta-analytic review of the underlying motives of willful ignorance and its consequences." Psychological Bulletin (2023). **Shahar Hechtlinger** (Max Planck Institute for Human Development, Germany) for the paper "The psychology of life's most important decisions." American Psychologist (2024).

In his acceptance speech, Professor Teigen reflected with characteristic humor and insight on a lifetime devoted to understanding how people think and talk about uncertainty. His talk revisits themes that have shaped decades of his work, from verbal probabilities and framing to the subtle pragmatics hidden in everyday language.

Judgment and Decision Making Journal — Call For Co-Editor

We announce a call for co-editorship of <u>Judgment and Decision Making (JDM)</u>. Jon Baron is the founding and incumbent editor, who will default to Associate Editor. The remaining co-editors are Mandeep K Dhami and Andreas Glöckner.

Association for Decision Making (EADM) and the Society for Judgment and Decision Making (EADM) and the Society for Judgment and Decision Making (SJDM). It is published by Cambridge University Press. The journal publishes peer-reviewed scholarly papers. All papers are open-access.

The journal seeks to publish articles that are of high-quality and interest to scholars working in the field of judgment and decision-making (JDM). The study of JDM concerns the normative, descriptive, and prescriptive analysis of human judgments and decisions. These topics may be studied from theoretical or applied perspectives, with the use of experiments, surveys, analysis of existing data, and other necessary approaches. The journal covers relevant content from several fields, including cognitive psychology, experimental economics, and experimental philosophy. The journal publishes mainly experimental work that contributes to our understanding of JDM behavior and theory development. Articles that suggest new or improved theories, cover methodological contributions, and include non-experimental work may also be published.

JDM is a key journal for the field. The role of editor includes maintaining the standards of scholarship. There is no remuneration for this position and we encourage colleagues to volunteer for the important and necessary function of this editorial work. The workload varies over the course of a year, and the work requires flexibility. However, candidates ought to reserve about half a day per



week (4 hours) for screening of submissions for desk rejection, which may involve providing reasons, or for assignment to action editors, who may seek further information. More time is required if the editor chooses to action edit a manuscript themselves.

We anticipate that candidates will have demonstrated scientific and scholarly excellence in one or more areas of JDM, as well as a breadth of knowledge in other areas such as Psychology and/or Economics. Other relevant qualifications may include prior experience as an associate editor or editor of another journal, a broad intellectual perspective, a commitment to scientific integrity and open science, knowledge of advanced quantitative analytic techniques, exceptional communication skills, and strong management skills, as well as an ability to work collaboratively with others.

Please submit a CV to **journal@sjdm.org** which can speak to the sorts of criteria mentioned above. The search committee will include Jon Baron, Mandeep Dhami, and Andreas Glöckner (co-Editors), and two members of the advisory board (representing EADM and SJDM). Both nominations and self-nominations are welcome. Please ensure that nominated candidates are willing to take on the position.

The deadline for receiving (self-)nominations is **15**th **January 2026**, when the review process will begin. Shortlisted candidates may be expected to attend a (virtual) interview with the search committee. Candidates should be prepared to begin receiving manuscript submissions from **June 1**st, **2026**.

The book provides an in-depth overview of contemporary research on decision making. It explores the foundations, mechanisms and consequences of human decisions from a multidisciplinary perspective. The chapters include reviews of experimental research on the cognitive and neural mechanisms underlying decision making in healthy humans, investigations of patient populations to identify how specific diseases alter decision processes and philosophical as well as ethical discussions around the topic of decision making.

Research Highlight

How behavioural systems shape climate adaptation decisions of policymakers (Bellmann, de Vries & Scholte, 2025)

Why do climate adaptation efforts advance slowly, even when solutions are known and feasible? As of today, research has primarily concentrated on citizens to understand this so-called adaptation puzzle, while policymakers' decision-making has received less attention. However, they play a central role in shaping the



trajectory in which a society adapts, with their decisions having potential systemwide impacts.

That is why we recently researched the behavioural dynamics that shape Dutch policymakers' climate adaptation decision-making. Based on data from interviews and a workshop, we developed a behavioural system map, which visualises cause-effect relationships between actor behaviours and underlying determinants. We identified nine themes that describe dynamics shaping climate adaptation policymaking. For example, policymakers search for precedents of successful projects that they can use to convince their political and administrative leadership that a climate adaptation project is feasible.

Through analysing the themes and the behavioural system map, we revealed three levers for system change: supporting precedent identification, stimulating information gathering, and boosting mainstreaming processes. These levers present points in the system in which behavioural interventions could unfold system-wide impacts via ripple effects across multiple behaviours. By integrating behavioural insights and systems analysis, our study proposes a novel approach to analysing contextual, dynamic influences and determinants of behaviour that shape adaptation policymaking.

NEW FUNDING

Despite significant efforts in the last 20 years to expedite cancer diagnosis, a substantial proportion of cancers in England (45%) are still diagnosed at a late stage, making treatment less effective and dramatically reducing survival prospects for millions of patients. Olga Kostopoulou from Imperial College London was recently awarded a grant from Cancer Research UK to study the impact of Alpowered Ambient Voice technologies ("digital scribes"), which can transcribe the entire patient-doctor interaction in real time. Their adoption in clinical practice is steadily increasing. The research programme will explore how the use of these tools shapes clinical reasoning and decision making, and if they can improve early cancer diagnosis. It will combine behavioural and computational approaches to analyse the clinical encounter and establish if/how real-time support for cancer detection can be built into digital scribes. Jay Russo is a collaborator on the grant, which also includes clinicians and computer scientists. The programme will employ 3 researchers, including a cognitive psychology postdoc for 3 years to be based with Olga at Imperial, starting in the first quarter of 2026.
